In order to use this service, your teen must attend a school in the Folsom-Cordova Unified School District and must be a current member of the HYDE Out with registration on file. The HYDE Out Teen Express Reminders

Members may ride as many days as they would like every week.

Attendance will be taken in the van every day. Spots on the express are reserved for participants who are signed up for The HYDE Out Membership **ONLY**.

This transportation program is designed to allow students to come and enjoy the after school program. It is not a means for them to be transported to Hagan Community Center and then walk home after school.

It is important that each teen is on time to the van after school. The driver does not wait for late students.

If your child can no longer ride the express due to after school sports, clubs or other engagements, a phone call to the program coordinator of The HYDE Out is mandatory. This will allow time to fill that spot on the express from our waiting list.

Food and drinks are not allowed in the vehicle at any time.

All taxi participants are expected to follow all HYDE Out Teen Center policies while riding in the vehicle. Participants that have behavior issues in the van or at the teen center will be removed from the service.

The express service DOES pick up early on minimum/Super minimum days.
