Notice to Picnic Facility Users

- 1) Pursuant to Public Resources Code Section 5782.21, governing the operation of the District, the following Rule No. 17, Rules & Regulations Governing Use of District Facilities, is as follows: “It shall be unlawful for persons at any time to operate an automobile or motor vehicle in a park unless such motor vehicle or other conveyance is on a street or paved lot.
- 2) All motor vehicles entering Hagan Community Park are subject to the appropriate entrance fees as posted at the entrance gate. Individuals can purchase annual permits, while persons without annual permits will be subject to the posted daily entry fees including same day re-entry fees.
- 3) Any group reserving a picnic area at Hagan Community Park may purchase a vehicle entry fee for \$2.00 per vehicle. Payment in full is required at least three working days prior to the date of your activity. Groups pre-paying vehicle entry fees are still subject to same day re-entry fees.
- 4) Your group is urged to clean up your area after your activity by placing all trash in cans or plastic bags. This is your Park; therefore we are requesting that you “pitch in” to help keep it clean.
- 5) Please be advised that the entrance gate to Hagan Park will be closed and locked at 10:00 p.m.
- 6) No amplified music will be permitted in the Park.
- 7) Renter agrees to protect, defend, and hold harmless **Cordova Recreation and Park District** and their elective or appointive boards, officers, agents, and employees from any and all claims, liabilities, expenses or damages of any to property, resulting here from, arising out of, or in any way connected with performance of the Reservation Agreement by Renter, Renter’s agents, officers or employees, subcontractors, or independent contractors hired by Renter. The only exception to Renter’s responsibility to protect, defend, indemnify and hold harmless **Cordova Recreation and Park District** is due to the sole negligence of the **Cordova Recreation and Park District**, or any of their elective or appointive boards, officers, agents or employees.
