Event Overview

Trunk-or-Treat provides a safe and fun trick-or-treating experience for hundreds of youth in the area that takes place in the Hagan Community Center parking lot. Organizations, local businesses and individuals are invited to decorate their cars and hand out treats from their trunks. This is a great opportunity for organizations to share information with the community by passing out flyers and promotional items to attending families (selling items or services on site is prohibited). Families will walk up and visit each trunk, collecting treats and admiring your creativity.

Event Details

There is no cost to register for a space but each car is responsible for providing their own decorations and treats. Treats must be store-bought (no homemade goodies) and individually packaged. Please note that pop up tents/E-Z Up canopies are prohibited due to fire code. Decorations can be as elaborate or as simple as you wish. However, as this is a family friendly event, please refrain from extremely spooky or gruesome decorations. Vendors may begin setting up as early as 1 p.m. and must be done by 2:30 p.m. For the safety of our guests and staff, vendors are asked to stay to the end of the event. We anticipate about 1000 people in attendance.

COVID-19 Guidelines

For social distancing purposes, trunks will be spaced out in the parking lot. Representatives are required to wear masks and gloves for the entire duration of the event regardless of vaccination status.
